RULES & REGULATIONS

1. The Owner of each nominated horse must be a member of the T.A.H.C. for 2009 (Dues 20.00)
2. All nominated horses must be registered in the ApHC, Inc. registry (for show or race) by the day of the show and copy (front and back) must be submitted with final payment.
3. The eligibility of any horse to be shown in this futurity will be transferable with a change in ownership, but a notification to the TAHC, in writing, is required immediately and prior to September 20, 2009.
4. **Monies and Awards:** Added money, plus 75% of entry fees will be paid back. Monies to the top five places in each respective division on the basis of 41% to first, 25% to second, 16% to third, 10% to fourth, & 8% to fifth. If less than six, management will adjust.
5. **Refunds: NONE unless class is cancelled**
6. Rules governing the Jim & Georgia Wales Non Pro Halter Futurity will follow the ApHC Non-Pro rules with the following exceptions: 1) that owner showing may be any age 2) Non-Pro cards not required.
7. **If less than six entries per class, the class will be cancelled and monies refunded.** There is a possibility of sexes being combined to make a full class.
